In cases where there was more than one variable for the question, the convention was to use A, B, C..., or AA, AB, BA, BB (see question MQB3AA as an example).

While an attempt has been made to capture the **skip patterns** in this documentation, please refer to the questionnaire for a more thorough understanding of these logic paths.
